When you arrive:

All visitors entering GAO facilities must undergo security screening and are subject to search. Please allow at least 15 minutes for the screening process as there may be lines. If you arrive and the meeting is in session, please enter quietly.

While the visitors entrance is on the G Street side of the building, FASAB visitors for the August 28-29, 2013 meeting must **enter through the H Street entrance**.

Visitors must provide the Receptionist or Security Officer at the access point with a valid picture ID (e.g., driver's license, etc.), purpose of visit, FASAB point of contact (Charles Jackson), and destination in the building (Room 1N37).

All visitors must pass through a magnetometer and have their belongings scanned through an x-ray machine. Other methods of screening, such as hand-held metal detection devices and physical or visual inspection may also be used.
